**ELIGIBLE ARTISTS:**

All members of the SLO Art Center OPAG and Morro Bay Art Association as well as San Luis Obispo County artists.

**ELIGIBLE ARTWORK:**

Only original oil, pastel, acrylic and mixed media paintings are eligible. The exhibition will be judged from CD's only, mailed or hand delivered to the SLO Art Center OPAG by May 5, 2010. Up to three entries allowed per person, with only one to be exhibited, should it be selected by the Juror for inclusion in the exhibition. The SLO Art Center OPAG and the Morro Bay Art Association Gallery reserves the right to omit work if it is inconsistent in quality with the submitted image, is poorly framed, or has otherwise been misrepresented. All entries must be wired, ready to hang with wire ends taped. No CD's will be returned.

**LIABILITIES AND RESPONSIBILITIES:**

The SLO Art Center OPAG and Morro Bay Art Association Gallery will not be responsible for loss or damage of any artwork. No artwork allowed to be removed prior to the end of the exhibit.

**THE JUDGE:**

David Limrite, BFA from the Art Center College of Design, Pasadena, CA. For the past 19 years Limrite has been both an instructor and now the current Director of the Brentwood Art Center, Los Angeles. As David states "My creations reflect my interest in the heroic, monumental, solitary figure - alone and at odds or in harmony with themselves and/or the world."

**SALES:**

All work must be for sale. Prices may not be changed. Sales commission of 40% is required by the SLO Art Center OPAG/ MBAA Gallery. Payment will be made to the artist by the 15th of the month following the month of sale.

**ENTRY AND FEE INSTRUCTIONS:**

**ENTRIES:** Up to three entries per person. Only one artwork per artist will be chosen for exhibition if it meets the jurors exhibition standards.

**SIZE:** no side dimension to exceed 48 inches.

**MEDIA:** original oil, pastel, acrylic or mixed media.

Submit one jpeg image for each artwork entered all on one CD. We recommend a file of 250 dpi with the longest dimension being 6 inches. Label each image with artist name, artwork title, and size.

The non-refundable entry fee for up to three pieces of artwork is \$35 for OPAG and MBAA members and \$55 for non-members. Acceptance and sale of artwork is not guaranteed. Make checks payable to OPAG.
